Applicants have proper government-issued, photo identification that matches the name on the applicable FAA Form.

A&P Course Certificate of Completion

A Certificate of Completion will be issued that states the applicant has completed the course and is prepared to take the Oral and Practical exam with a designated mechanic examiner.

Performance and Attendance

Student understands that he/she must attend every scheduled class and is expected to self-study each evening after class, as well as during the weekend between week 1 and week 2. It is the student's responsibility to ask for further instruction, clarification, or other assistance as needed, in order to keep up with the daily progress of the class. Students must be punctual and arrive to class no later than 9:30 a.m. each weekday. Students who are tardy or request leave in advance will be allowed to make-up work after class. In the event a student cannot complete the course as scheduled, the student may return to the school and attend the next regularly-scheduled class based upon availability.

Students are expected to attend all of the scheduled course dates. Classes are held each day from 9:30 a.m. until course material is completed for that day. A 1-hour lunch break will be given, with additional, short breaks throughout the day. Please note these times may vary depending on course workload.

Once a student has paid and attended a course, he/she may return and attend a future course until required exam(s) for the license are passed. Please note that exam retest fee will apply.



Payment Policy

A&P/IA Payment Policy

The A&P/IA courses are designed to help you pass the FAA written and the Oral & Practical exams.

In order to reserve a seat in the class for the selected course and date, full payment is required in advance on a first come, first serve basis.

If for some reason you are unable to attend the selected course on the selected date, you may apply your payment to a future class. No refunds will be issued.

If you do not pass your written examinations, you may attend future classes at no additional charge. The cost of written exams is separate from the class and must be paid each time an exam is taken.

If you are unable to keep up with the class, we will work with you to get you through each section of the course. You may need to attend future classes in order to complete the license in which you are trying to achieve. There is no additional charge for extra classes that you attend, however, the cost of the written exams and Oral & Practical exams is separate from the class and must be paid each time an exam is taken.

Since we have no control over written exams and DME fees, we do not include them in the cost of this course. If you are Air Force COOL or any other entity that paid for these fees in advance, you are responsible for any price increase that may have occurred after payment was made.

No refunds will be given for failed written exams.

No international credit cards will be accepted. If you do not have a credit card that has been issued in the United States, you must pay in cash (US Dollars).

Students who are deemed by the instructor to be: disruptive, inappropriate, unlawful or other such conduct will be dismissed from the class and will NOT be eligible for class make-ups or any payment refunds.
